I understand that if for any reason that either the Miss or Jr. Miss Highlands County cannot fulfill her obligations, the Highlands County Fair Association will ask for the first runner up to resume for the remainder of the year.

I understand and agree that the method and manner of judging at the Miss & Jr. Miss Highlands County 2012 Pageant and supervision of awards shall be the sole responsibility of the Pageant Committee. The decision of judging regarding the selection of the winner shall be final.

### **Ages**

Miss Highlands County contestants must be at least 16 years of age by February 1, 2012; you may not be older than 19 years of age.

Jr. Miss Highlands County contestants must be at least 12 years of age by February 1, 2012; you may not be older than 15 years of age.

### **Entry Fee**

There will be an application fee of \$50.00 and sponsorship fee of \$25.00 due upon registration. Please have checks made payable to Highlands County Fair Assoc. **Both fees are due by January 27<sup>th</sup>**

### **GPA**

You must carry at least a 2.0 GPA on a 4.0 scale. You must bring a copy of your current GPA along with you to January 27<sup>th</sup>
