The Highlands County Fair, the Junior Livestock Rules Committee, and the Junior Livestock Show Committee hereby have the right to dismiss or excuse an animal from the fair. If any animal is dismissed or excused from the fair the animal, and related expenses will be deducted from the total rail price. Once all expenses are paid I will receive the remaining money for the animal.

Chapter 5C-4 Admission of Animals for Exhibition

5C-4.001 General Requirements and Limitations

- 5C-4.001(1)** Official Certificate of Veterinary Inspection (OCVI) Required. All Animals for exhibition in Florida, unless specifically exempted, must be accompanied by an OCVI issued by a veterinarian accredited in the state of origin.
- 5C-4.001(3)** Exemption to Required OCVI. An OCVI is not required for animals' origination in the State of Florida and entered in market classes provided that the animals are segregated from other animals and the pens are occupied only by the animals in a market class. Pens used for market classes must not be reused until after cleaning and disinfecting.

5C-4.0015 Definitions

- 5c-4.0015(8)** Market Class. An exhibition class consisting of finished fed animals where all animals in the class go directly to slaughter immediately following the exhibition.

5C-4.002 Cattle

- 5C-4.002(3c)** Cattle from non-quarantined herds originating from Class A areas are exempt from brucellosis test requirements provided that the cattle are:
- Under 18 months of age; or
 - Official calfhood vaccinated of beef breeds under 24 month of age; or
 - Official calfhood vaccinated of dairy breeds under 20 months of age; and
 - Not parturient or post parturient

5C-4.003 Swine

- 5C-4.003(2a)** Test or Certification Required. Brucellosis. All breeding swine over six months or age entered for exhibition, excluding barrows and gilts in market classes, must originate from a Validated Brucellosis-Free Herd, as defined in 5C-6.008, Florida Administrative Code, or must be recorded negative to a brucellosis test within 30 days of the date of exhibition. When validated, the validated herd number must be on the OCVI.
- 5C-4.003(2b)** Pseudorabies. All breeding swine over six months of age entered for exhibition, excluding barrows and gilts in market classes must originate from a Qualified Pseudorabies-Free Herd, as defined in rule 5C021.005(2), Florida Administrative Code, or be negative to a pseudorabies test within 30days of the date of exhibition. When qualified, the qualified herd number must be recorded on the OCVI.
